The regular meeting of the Westville Town Council was held at the Westville Town Complex Community Room, 100 Setser Drive at 7:00 p.m with Michael Albert present and everyone else attending virtually. Present: Michael Albert, Regina Ruddell, Tom Fath, Olga Pothorski, James Bechinske, Lori Mercer; Clerk-Treasurer, Town Attorney, Doug Biege.

A motion was made by Tom Fath to approve minutes of the January, 2021 meeting. James Bechinske, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

A motion was made by James Bechinske to approve claims for the month of January, 2021. Michael Albert, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

UTILITIES

Tom Fath gave a brief summary of the MCO report for January. It is attached.

Tom Fath stated that we will need to start looking into an OCRA grant for the west side of town as far as the underground pipes go since the last water main break we had resulted in a large loss of water due to the pipes being old.

Tom Fath discussed the rate study agreement between the Town and Baker Tilly in regards to leaf/limb pickup fees, hydrant fees, and trash rate increases. Michael Albert asked if we could roll this rate study in with the sewer rate study that they will already be doing for the Westville Correctional Facility project. Tom Fath stated that we will table this until next month to give us time to contact Jeff Rowe from Baker Tilly to see if we can roll this all together.

Michael Albert read Resolution 2021-4, Uncollectable Utility Accounts. Michael Albert made a motion to adopt Resolution 2021-4. Tom Fath, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

Tom Fath reported on the McMahon Engineering memorandum regarding the water tower in Water Tower place. This tower will need to be painted within the next couple of years. The estimated cost to paint this tower would be approximately \$243,870.00. There are enough funds in the water operating fund to cover this cost. Council agreed to have McMahon Engineering move forward with getting specs together for this project. Tom Fath will reach out to McMahon.

James Bechinske asked about the old water tower and Tom Fath reported that the best option would be to tear it down. Tom Fath stated that he will get the recommendation in writing from the company that recommended this in the past.

STREETS

James Bechinske discussed the possibility of getting a generator for the town garage. They have received two quotes from Current Electric (attached). The quote for a generator at the new building is \$6,700.00. This could be 16 weeks out before one is available. James Bechinske also reported that we can move the old generator from the old town hall to the old part of the town garage and the cost for that would be \$2,400.00.

James Bechinske made a motion to accept the bids from Current in an amount not to exceed \$10,000.00. Michael Albert, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

PARKS

There was nothing to report in parks.

Mike Albert recommended that the council allow Tri-Kappa to use Prairie Meadow Park for free for their May flower sale. Council agreed.

POLICE DEPARTMENT

Monthly stats were not reported.

Regina Ruddell reported that Darin Mercer is retiring from his position as Town Marshal, effective February 13, 2021. She also stated that this position was posted internally and Chief Deputy, Nathan Hynek submitted his application and resume. The personnel committee interviewed Chief Deputy, Nate Hynek and the decision to hire him was unanimous. As part of the Personnel Committee, Regina Ruddell made a motion to hire Chief Deputy, Nate Hynek for the Town Marshal position, effective February 14, 2021. Mike Albert, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

Marshal Mercer reported on the Report Management System. He reported that when the county received the grant for this, the Town of Westville was not included in this grant. Moving forward, Chief Deputy, Nate Hynek will have to find a way to fund a reporting system for the department, whether it be outside funding, private solicitation, etc.

Nate Hynek reported that since Marshal Mercer is retiring, there will be a need to raise the \$5,000.00 amount for part-time staff, that was approved at last meeting, to \$10,000.00.

Nate Hynek reported that he will be appointing Joe Walker to the Chief Deputy position, effective February 14, 2021.

Michael Albert read Resolution 2021-1, Salary Ordinance Amendment for the year 2021. Michael Albert made a motion to approve Salary Ordinance 2021-1 on the first reading. Tom Fath, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

Michael Albert made a motion to suspend the rules and adopt Ordinance 2021-1. Regina Ruddell, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

FINANCE

Michael Albert made a motion to cancel the outstanding checks that are over 2 years old in the water deposit account, totaling \$18.94, which will be put back into water operating. The sewage deposit outstanding checks total \$41.40, and this will be put back into sewage operating. Tom Fath, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

MISCELLANEOUS

Max Correa's position on the Board of Zoning Appeals (BZA) expired on Jan. 8, 2021 and he is interested in staying on the BZA. This position is appointed by the Town Council President and it is a 2-year term. Michael Albert appointed Max Correa to the BZA with a term to begin 1/8/2021 through 1/8/2023.

Michael Albert reported on the employee spending authorization limit. This limit is currently set at \$1,000.00. This spending limit will exclude day-to-day operations for every department that typically have items/invoices that are over \$1,000.00. Examples are utility bills, chemicals, fuel, repairs and maintenance, etc. Michael Albert made a motion to approve the exclusions. Tom Fath, second. Roll Call: Ruddell, yes; Pothorski, yes; Bechinske, yes, Fath, yes; Albert, yes.

CITIZENS COMMENTS



Water

- 1. GIS -Nothing new to report.
- 2. The INDOT roundabout and culvert replacement projects are proceeding.
- 3. Mc Mahon evaluated the small tower. Their letter is attached.
- 4. The water audit is complete. We met with Wessler to discuss it. The water loss is about 20% which is somewhat high. We are looking into finding the source. We will begin by having the plant master meter tested.
- 5. There was a major water main break on 2/3/21. There was huge hole blown out the side. The water plant could not keep up with the loss of water. Randy and Adam got on the valves and throttled them down to a manageable flow. Weston Excavating and ACUDIG were on site. When we found the problem we had D&M come to repair it. There was a boil order issued.

Wastewater

- 1. The Nash Finch Lift Station still needs a flow meter installed. We have contacted McMahon for their help in getting a contractor interested in installing the meter and vault. The station is seeing increased flows due to the increased traffic at the Dollar General facility. We have not yet begun to work on this.
- 2. The Westville Estates pump station is deteriorating rapidly. We have spoken with McMahon to renovate the station.
- 3. We continue to spend much time on the DOC renovation project.
- 4. We lost alarm callout capabilities due to the PLC screen having a failure. MB Controls corrected the problem.

Westville 200,000 Gallon Elevated Water Tank Observations

The Town of Westville Indiana municipal water system includes a 200,000-gallon, ellipsoidal style, elevated water tank. The tank was built in 2002 and has its original paint system on the tanks interior and exterior.

The tank's wet interior was inspected on November 1, 2019 by Midco Inspection, with the tank full of water using a diver. A video of the inspection was provided to the town. From the video, the following observations were made.

Wet Interior

- The tank had a minimal amount (<1/16") of sediment evenly distributed across the tank bottom. The sediment on the floor was removed as part of Midco's inspection.
- The walls and floor of the tank interior had some iron staining.
- There were approximately 15 to 20 rust nodules or blisters in the coating system on the floor and lower sidewall. The blisters and nodules appeared to range from 1/2" to 2" in diameter. Midco removed the loose paint, wire brushed the bare steel and re-coated the steel with Aquatapoxy coating.
- There were large loose pieces of paint on the floor of the tank. The pieces of paint were from the ceiling where areas of the topcoat had delaminated from the intermediate coat.
- There was some corrosion on the access ladder. The fall protection safety cable does not appear to be made of stainless steel, as some rust was developing on the cable.
- The walls of the tank appear to be in good condition.
- There is a 5"-diameter pipe that appears to penetrate or is attached to the tank bottom and runs into the riser column. The pipe has a small pipe attached to the top of the pipe. The purpose of the pipe is unknown.
- A section of the plate at the top of the riser column was cut out for the 5"-diameter pipe to go through. This could be a structural issue and should be addressed.



- There appears to be a ladder in the riser column.
- There is a railing attached to the tank floor, around the riser column.
- At the high-water line, there is iron staining and what appears to be some breaks in the coating
- The overflow structure has rust along the bottom edges.
- The roof inside of the tank has several linear spots of paint failure. These paint failures may be due to heat damage from welding on the exterior roof of the tank.
- There is rust around the vent opening in the roof.
- There is paint delamination on the roof of the tank. It appears that the delamination is between the topcoat and intermediate coats. The area of delamination is approximately 3-feet long by 2feet wide.
- The tank does not appear to have a cathodic protection system for the wet interior.

Exterior

- The concrete foundations for each of the four tank legs appear to be in good condition.
- No unusual settling around the foundation or site were observed.
- The overflow pipe discharges over a storm sewer manhole with a grated cover. The casting is several inches above grade, so much of the overflow water would probably run off to the surrounding grass area.
- The bottom of the ladder is about 9-feet above ground level. The bottom of the access ladder on the tank leg is covered to try and prevent access onto the ladder.
- Overall, the exterior coating systems appears to be in fair to good condition. Several areas of coating failures were observed from the ground.
 - o Rust is developing on weld seams on the riser column.
 - Several rust spots were on the plate steel of the riser column.
 - Rust is developing on the weld seams of the tank bowl at the lower curved section.
 - Some light surface rust appears to be developing on the sidewall of the tank.
- Algae/mold is growing on the belly of the bowl.

Recommendations

- The existing water tank is 19-years old and has not previously been repainted. Twenty years is the approximate expected life of the tank coating. Westville should start planning for recoating the water tank within the next 3 to 5-years, depending on how soon the rust develops. The tank exterior recoating should be done before the existing coating is in too poor of a condition to topcoat. Topcoating the exterior would consist of:
 - o Pressure washing.
 - o Power-tool cleaning of all rust spots to bare steel and priming.
 - Application of a tie-coat and topcoat.

Depending on the type of existing coating, it may be possible to eliminate the tie-coat before topcoating.



At the time of exterior topcoating, when the tank is empty, the wet interior should be repainted. The recommended repainting would be complete removal of the existing coating system and recoating. From the 2019 underwater inspection, the existing coating was in fair condition. Failures in the coating system are beginning to appear. Since the tank does not have a cathodic protection system, corrosion of the steel will start to occur once there is a break in the existing coating. The corrosion will continue and result in steel loss (pitting in the steel), which could lead to more costly repairs in the future.

Opinion of probable costs to topcoat the water tank exterior and completely repaint the interior is \$245,000. See attached.

ORDINANCE No.: 2021-1

AN ORDINANCE OF THE TOWN COUNCIL OF WESTVILLE, LAPORTE COUNTY, INDIANA, AMENDING ORDINANCE NO. 2020-10 ENTITLED "SALARY ORDINANCE FOR THE YEAR 2021"

WHEREAS, on November 10, 2020 the Town Council of the Town of Westville, LaPorte County, Indiana (the "Town Council") adopted Ordinance No. 2020-10 entitled "Salary Ordinance for the Year 2021"; and

WHEREAS, Ordinance No. 2020-10 established the salaries and other compensation to be paid to the employees of the Town of Westville, LaPorte County, Indiana (the "Town"), in 2021; and

WHEREAS, the Town Council is desirous of adopting this Ordinance to amend Ordinance 2020-10 to add a position and compensation for part-time Police Officers, General Fund Police.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WESTVILLE, LAPORTE COUNTY, INDIANA, THAT ORDINANCE 2020-10 SHALL BE AMENDED TO READ AS FOLLOWS:

Section 1. Page 2 of Ordinance No. 2020-10 is hereby revised and amended to state as follows:

- Section 3. If any portion of this Ordinance shall be held invalid or unconstitutional by any court or competent jurisdiction, such decision will not affect any other portion or provision of this Ordinance.
- Section 4. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. It is provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinances or parts of ordinances are hereby ratified, reestablished and confirmed.
- Section 5. This Ordinance shall be in full force and affect from and after its adoption and any procedures required by law.
- Section 6. All of which is Ordained by the Town Council of the Town of Westville, LaPorte County, Indiana by a vote of 50 of all members present and voting this 94 day of February 2021.
