Is our water safe?

This brochure is a snapshot of the quality of the drinking water that we provided last year. Included as part of this report are details about where the water that you drink comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and Indiana standards. We are committed to provide you with all the information that you need to know about the quality of the water that you drink.

Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised people, such as people with cancer undergoing chemotherapy, people who have undergone organ transplant, people with HIV/AIDS, or other kind of immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA has set guidelines with appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants which are available from the Safe Drinking Water Hotline at (800) 426-4791.

Where does our water come from?

The Town of Westville's water comes from two wells located in the Valparaiso Moraine.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of these contaminants does not necessarily indicate that the water poses a health risk or that it is not suitable for drinking. The sources of drinking water (both tap water *and* bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, or can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in the raw, untreated water may include:

- ***Microbial Contaminants***, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- ***Inorganic Contaminants***, such as salts and metals, which can be naturally-occurring, or that result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, and mining or farming operations.
- ***Pesticides and Herbicides***, which may come from a variety of sources, such as agriculture, stormwater runoff, and residential uses.
- ***Organic Chemical Contaminants***, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production operations, and can also result from gas stations, urban stormwater runoff, and septic systems.
- ***Radioactive Contaminants***, which can be naturally-occurring or the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations that limit the amount of certain contaminants that may be present in the water provided by public drinking water systems. We are required to treat our water according to EPA's regulations. Moreover, FDA regulations establish limits for contaminants that may be present in bottled water, which must provide the same level of health protection for public health.

Water Quality Data

The table below lists all the contaminants that we detected during the 2021 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise indicated, the data presented in this table is from testing done between January and December 31, 2021. The Indiana Department of Environmental Management (IDEM) requires us to monitor for certain contaminants at a frequency less than once per year because the concentration of these contaminants are not expected to vary significantly from one year to another. Some of the data, though representative of the water quality, may however be more than one year old.

Definitions

The following table contains scientific terms and measures, some of which may require explanation. Some of the terms and abbreviations used in this report are as follows:

- **Action Level Goal (ALG)** - The level of a contaminant in a drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.
- **Action Level** - The concentration of a contaminant which, if associated, triggers treatment or other requirements which a water system must follow.
- **Avg.** - Regulatory compliance with some MCL's based on running annual average of monthly samples.
- **Maximum Contaminant Level or MCL** - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- **Level 1 Assessment** - A study of the water system to identify potential problems and determine (if possible) total coliform bacteria have been found in our water system.
- **Maximum Contaminant Level Goal or MCLG** - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- **Level 2 Assessment** - A very detailed study of the water system to identify potential problems and determine (if possible), why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
- **Minimum Residual Disinfectant Level or MRDL** - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that neither a disinfectant is necessary for control of microbial contaminants.
- **Maximum Residual Disinfectant Level Goal or MRDLG** - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- **NA** - Either not available or not applicable.
- **Mrem** - Millirems per year (a measure of radiation absorbed by the body).
- **ppb** - Micrograms per liter or parts per billion – or one ounce in 7,350,000 gallons of water.
- **ppm** - Milligrams per liter or parts per million – or one ounce in 7,350 gallons of water.
- **Treatment Technique or TT** - A required process intended to reduce the level of a contaminant in drinking water.

<p>*Special Note on Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Note of Explanation – The 2021 CCR was delivered in time to all customers. IDEM did not receive a copy until September 2021 when the required verification form and CCR was submitted to them.			
Monitoring, Routine, Minor, (RTCR)	6/1/21	6/30/21	We failed to test our drinking water for the contaminant and period indicated. Because of this failure, we cannot be sure of the quality of our drinking water during the period indicated. <i>(The Revised Total Coliform Rule (RTCR) seeks to prevent waterborne diseases caused by E. coli. E. coli are bacteria whose presence indicates that the water may be contaminated with human or animal wastes. Human pathogens in these wastes can cause short-term effects, such as diarrhea, cramps, nausea, headaches, or other symptoms. They may pose a greater health risk for infants, young children, and the elderly.)</i>
Note of Explanation – The bacteriological sample in question was sampled properly and submitted to the LaPorte County Health Department lab in proper time. Apparently, the sample results were either not sent to IDEM by the lab or the results were lost or misfiled.			

Our water system is working with the community to increase awareness of better waste disposal practices to further protect the source of our drinking water. We are also working with other agencies and with local watershed groups to educate the community on ways to keep our water safe.
